
DB Secure Authenticator Software app (DBSA) settings

- Change your PIN on the DB Secure Authenticator Hardware Token -Hardware Token not ready to be offered by DB China
- Delete token on the DB Secure Authenticator Hardware Token-Hardware Token not ready to be offered by DB China

DBSA mobile app (software token)

- Launch the DB SECURE AUTHENTICATOR APP (DBSA)
- Insert six digit PIN in order to open the app
- Select DBSA settings option (top left corner of the app)






Function: Activate New Token

- Follow activation process




Function: Activated Tokens (delete)

- Use left gray button to scroll




Function: Language

- Confirm selection




Function: Change PIN (1)

- Enter PIN




Function: Change PIN (2)
